# The Mayor's Electric Vehicle Infrastructure Task Force



CRP has been invited to join the Mayor's new Electric Vehicle (EV) Infrastructure Taskforce chaired by Shirley Rodrigues, Deputy Mayor for Environment and Energy.

The 16-member Taskforce was launched on 31 May 2018. It will provide guidance on how to implement the Mayor's vision of a zero emission transport network by 2050, focusing on the lack of electric vehicle charging infrastructure that remains an important barrier to the take-up of EVs.

Based on previous and ongoing work such as <u>FREVUE</u>, <u>Smart Electric Urban Logistics</u> as well as our recent report on <u>Electric Freight Vehicles in Central London: Local Grid Capacity</u>, CRP will be glad to contribute to the Taskforce discussions feeding into a shared EV Infrastructure Delivery Plan to be published next year.



West End Partnership Freight and Servicing Strategy

CRP have brought together public, private and community sector partners as part of our role coordinating the West End Partnership's <u>Deliveries and Servicing Group</u>. Pooling this wealth of local knowledge and industry expertise, the strategy is aiming to address the movement of goods and servicing activity across the West End, acknowledging the diversity of this unique area and its importance in the London and UK economy.

## **Smart Electric Urban Logistics Launch Event**



At the UPS Sustainable Logistics event on 19 June <u>Smart Electric Urban Logistics</u> (SEUL), partners invited stakeholders, funders and partners to officially launch the project. Shirley Rodrigues, Deputy Mayor for Environment and Energy, opened the event underlining the importance of the electrification of fleets in addressing London's air pollution and the role a unique project such as SEUL plays in paving the way.

Taking place in an operational logistics setting at the UPS central London depot in Camden, the event allowed stakeholders to fully explore the challenges and opportunities around the electrification of fleets and low impact city logistics. At three stands, partners presented and discussed various elements of this work: 1) The UPS EV journey; 2) The smarter use of our electricity grid to enable fleet electrification and 3) low impact city logistics through the use of an electrically assisted delivery trailer.

#### **DEFRA 2017/18 Outcomes**



Over the past year, CRP has approached small-medium enterprises (SMEs) across Westminster and Camden to encourage them to take simple actions to make their deliveries processes more efficient, saving them time and money, while reducing negative impacts on local air quality and traffic congestion. Funded by DEFRA, the exercise is a 3-stage process that comprises:

- 1. having businesses complete a simple questionnaire to generate recommended actions;
- 2. engaging those businesses to take a closer look at their deliveries process; and, finally
- 3. supporting those businesses to implement one or more actions.

So far, the results have shown:

- More than the targeted number of 40 businesses have completed the questionnaire, raising their awareness of the general impact of deliveries of goods and servicing on local air quality;
- More than 90% of the targeted number of 40 business have engaged with CRP, improving their understanding of their business's impact on local air quality;
- To date, approximately 20% of the targeted number of businesses have actually taken pro-active, meaningful action, highlighting that small businesses may need more of an incentive to change their behaviour and overcome barriers (usually perceived, rather than actual) to change their deliveries process.

All of these lessons learnt are already being put into practice via CRP's second DEFRA Air Quality programme, Clean Air Villages (please see previous article).

#### **CLSRTP** and the LIP Process



London boroughs are currently in the process of drafting their <u>Local Implementation Plans</u> (LIPs). Each London borough is required to develop a LIP which sets out how the borough will deliver the 2018 <u>Mayor's Transport Strategy</u> (MTS) at a local level.

This is the third round of LIP development and the guidance documents have been provided by <u>Transport for London</u> alongside the MTS.

The CRP-managed <u>Central London Sub-regional Transport Partnership</u> (CLSRTP) will be hosting a special collaborative LIP meeting in July. This will enable the group to identify cross boundary issues that cut across all the central London boroughs e.g. air quality, traffic reduction and network planning etc. The meeting will allow for robust discussions and identify any potential for aligning policies. We will extend the invitation to include the London Boroughs of Hackney and Tower Hamlets.

Borough partners will then have the opportunity after the meeting to view <u>CRP's Clean Air Together</u>

<u>exhibition</u> that is running until 30<sup>th</sup> July at the New London Architecture (NLA) exhibition centre. Officers will be encouraged to make pledges on how they can contribute towards improving London's air quality.

## **Strategic Investment Pot Application**



Cross River Partnership recently submitted an application to the £52m Strategic Investment Pot (SIP), which is formed of retained, pooled London Business Rates. The SIP was made available to local authorities and multi-borough partnerships to apply.

We proposed bringing together the public and private sectors to help Londoners into good jobs in the Hospitality and Retail Sectors, support them to progress, and thereby support business productivity and growth across the central London sub-region. Westminster City Council kindly agreed to act as our accountable body.

## **Public Health England Study**



Public Health England have just released a comprehensive study on the impact of employment on people with disabilities and health conditions.

There are many compelling reasons to regard work and worklessness as important public health issues both at local and national level. Some of these are:

- · Having a decent job boosts our well-being and quality of life and protects against social exclusion.
- Conversely unemployment increases our risk of limiting illness and worsening mental health and impacts on families too.
- The longer we're out of work, the more likely it is to impact on our health.
- Health isn't just an individual issue and our communities and local businesses greatly benefit from a healthy and productive population.
- Helping people with health issues to obtain or retain work, and be happy and productive within the
  workplace, is a crucial part of the economic success and well-being of every community.
- The combined costs from worklessness and sickness absence amount to over £100b annually, which makes it very clear that there's an economic, as well as moral and ethical case, for greater action.

Cross River Partnership delivers a number of projects to support unemployed disabled jobseekers into work, including two specialist employment initiatives working with Westminster residents, and our innovative Camden Council-funded CamdenAbility, which supports with disabled residents in Camden into work.

CRP's Recruit London Team of Workplace Co-ordinators (WPCs) continue to be extremely busy supporting unemployed residents to bring them closer to the jobs market, and to continue supporting them once they have started work. Below is an update on the past month's activities:

The **Camden Specialist WPC** who supports Camden residents with physical and learning disabilities has provided employment support to 19 new candidates; two candidates have secured employment in care work and as a glasswash technician, the latter following an employer site tour. Employer site tours such as the one recently organised with the Francis Crick Institute enable candidates to get a good insight into possible jobs they could do which they may not have otherwise considered. The WPC has also delivered four workshops to engage more candidates, signed up four new employers to the Camden Ability Network and secured work experience placements at UCL. The **Heart of London WPC** has supported 53 candidates into employment in nine months and in the last month arranged two employer workshops with McDonalds - Capital Arches Group and The Ritz, who are Heart of London Business Alliance members.

12 candidates attended the workshop which enabled them to learn more about the Capital Arches Group expectations as an employer, training opportunities, benefits and career progression with McDonalds. Following the presentation all 12 candidates were interviewed and successfully passed the first stage interview and have progressed to the second stage interview with the employer. In addition, Natalie, who expressed an interest in sustainability issues, was helped to secure work as a Coffee Cup Ambassador with Veolia. The **ReStart WPC** who supports residents who are homeless or at risk of homelessness has engaged with a range of The Crown Estate business tenants to secure job opportunities for the client group. A case in point is Greg, a candidate who was homeless, and with support has been able to turn his life around and in turn help his family to improve their circumstances. Westminster & CapCo WPCs and Specialist WPCs support Westminster unemployed residents. The team have been busy screening candidates with a range of employers such as Dishoom, Venchi, Whittard, Daniel Galvin, Shake Shack and Hamleys. Maintaining a stream of work-ready candidate referrals is key to meeting employer demand and the team circulate the vacancies on offer on a weekly basis to referral partners such as Jobcentre Plus, Central & North-West London NHS Trust and to colleagues in other Westminster City Council departments. One candidate, Chloe who was supported to secure a seasonal role with Hamleys, has now through her hard work and determination successfully secured a permanent contract. The Forum's aims are to:


- develop and promote local authority arts and cultural provision across the capital;
