Local Government Elections on 3rd May 2018



Local authorities will be entering the pre-election period leading up to the forthcoming local government elections on 3rd May. The period between 26th March and 3rd May, known as Purdah, means that basic principles surrounding impartiality and publicity must be followed closely during the period of heightened sensitivities.

DEFRA Funding for CRP's Clean Air Villages



CRP has secured the second largest share (£282,850) of DEFRA's latest Clean Air Grant for our Clean Air Villages programme, a partnership between five boroughs: Lambeth, Hammersmith and Fulham, Islington, Kensington and Chelsea, and Lewisham.

Clean Air Villages will reduce emissions at 10 air quality hotspots across the five boroughs, by working with businesses and communities to make deliveries and servicing more efficient through individual and collective action.

The programme builds on CRP's successful <u>deliverBEST programme</u> and DEFRA-funded pilot in Camden and Westminster in 2017/18.

Importantly, both business as well as trade press covered the project, another sign that electric freight vehicles are moving from the sustainability niche into business mainstream. A launch event in summer 2018 will allow interested stakeholders to visit the UPS central London site and see the electric vans, charging infrastructure and system first-hand. CRP is producing new 'Click. Collect. Marylebone Low Emission Neighbourhood Play Street



The Marylebone Low Emission Neighbourhood (LEN) programme was established in 2016 after a successful bid by <u>Westminster City Council</u> to the <u>Mayor's Air Quality Fund</u>.

One strand of this work to help tackle air quality is a school engagement programme which has seen children from schools in the LEN take part in dedicated air quality lessons and activities. Building on the success of delivery partner <u>Sustrans</u>' work with the Eco Team at <u>Halcyon International School</u>, a play street was held nearby, with a small section of the street outside the school closed to vehicles for a short time.

The play street featured a space for BMX stunts, basic cycle training, a market for restored bikes and DIY bike jewellery, a mobile air quality monitoring station, a parklet, and smoothie-making / music-generating bikes.

CRP programme manages the LEN, so as well as providing information on the day, we took along our portable garden and asked people to sit down, relax and consider what the streets of the future should look like. As you can see, the future of urban design is in creative hands!

Heart of London Business Alliance Deliveries Update



Coming to the end of a full year of delivery on the Heart of London Deliveries & Wastes programme, CRP is proud to have to delivered with and on behalf of the BID:

- Assessment and selection of 3 preferred suppliers: Anglo for office suppliers and WCC and Paper Round for commercial waste services;
- Held two events: The Clean Air Launch event on May 23rd 2017 and a Drop-in workshop for businesses to meet preferred suppliers on 13th February 2018;
- Secured additional funding of £42,400 from TfL for a waste consolidation programme in Leicester
 Square to reduce vehicle movements in central London;
- Supported Westminster City Council/Veolia's introduction of on-street coffee cup recycling, leading the way in The West End;
- Engaged with 100 different businesses in the Heart of London area;
- Produced an animated video for recycle week with a reach of over 250 views.

Recruit London 2018/19 Contract



For 2018/2019, Westminster City Council has funded Recruit London to continue to support unemployed Westminster residents into work. Our focus is candidate facing (assessments and sector/role specific training, preparation for interviews and assessments) and employer facing (vacancy sourcing, recruitment planning, support with preparing personal specifications, job matching, sifting applications and assisting with interviews). We will continue to provide a free local service to businesses, promote vacancies to attract eligible candidates, deliver job specific training and support to candidates, screen and broker candidates into employment, and support the employer and candidates for 6 months to sustain employment.

Our focus for 2018/2019 is on working with more people that are further away from the job market, for instance ESA to JSA claimants, 12 months plus unemployed or economically inactive candidates. This

also includes a focus on working with candidates with disabilities, long term health conditions, people who are homeless or who face other significant barriers.

CRP is grateful to additional funders of its Recruit London service, including <u>Capital and Counties</u>, <u>Heart of London Business Alliance</u>, <u>London Borough of Camden</u> and <u>The Crown Estate</u>.

London Mayor's Construction Academy



The Mayor's Construction Academy (MCA) Programme has launched with the opening of the opportunity for construction skills training providers to apply for the Mayor's Construction Academy (MCA) quality mark. Full details are available on the GLA website via the following link:

The MCA Programme consists of three parts: the MCA quality mark; revenue funding to create MCA hubs to strengthen co-ordination between construction skills training providers and construction sector employers; and capital funding for equipment and facilities to support the delivery of high-quality construction training provision in London.

The launch marks an important stage in addressing the skills challenges of the construction sector across London and ensuring the industry has the capacity to help achieve the ambitious housing targets that are described in the draft London Plan.

King's Commission on London 2030




On 15th March, the Policy Institute published the report of the King's Commission on London. Launched by the Mayor of London Sadiq Khan at City Hall, the report examines three key areas of the city's long-term future through to 2030 and beyond: its economic prospects, health policy needs and new arrangements for non-university skills training.

The Commission has been co-chaired by Lord (Andrew) Adonis, former Cabinet Minister and Transport Secretary, and Professor Tony Travers, Director of LSE London, and its members have included London leaders of business, government, think tanks and academia.

An independent Planning Inspector will now review feedback on the draft plan in advance of an Examination in Public later this year. The final London Plan is expected to be adopted in Autumn 2019.
