FREVUE wins LowCVP Low Carbon Champions Award



We are delighted to have won the <u>LowCVP Low Carbon Road Transport Initiative of the Year Award</u> for the FREVUE project.

The 4.5-year FREVUE (Freight Electric Vehicles in Urban Europe) project that was finalised in September 2017 deployed 80 fully electric freight vehicles (EFVs) across a range of logistics operations in eight European cities. The vehicles ranged from car-derived vans of under 3.5 tonnes to highly innovative 18-tonne trucks. In London, 16 UPS diesel delivery trucks were converted to electric as part of the project and are still in operation today. In addition, Clipper Logistics deployed a 10-tonne delivery truck from the Regent's Street consolidation centre in central London. The overall project was co-ordinated by CRP. The CRP team were delighted to receive the Clean Air Award at the <u>Fleet Hero Awards 2017</u> earlier this month.

The Award, from the Energy Savings Trust, recognises our Clean Air Better Business (CABB) programme's innovative, co-ordinated and holistic approach to addressing air quality.

The judges noted the CABB programme's holistic engagement at individual, local and business levels, through the 'Click. Collect. Clean Air.' behaviour change campaign, deliverBEST business support service, clean air walking routes and local BID-led publicity and information campaigns.

CABB is funded by the Mayor's Air Quality Fund and matched-funded by CRP partners. Together, CRP and partners have advised over 200 businesses on deliveries and servicing, delivered London's first clean air walking routes and high profile local environmental improvements including FitzPark and Brixton Orchard.

West End Partnership Draft Freight Action Plan



CRP is developing a draft Freight Plan for the West End, as part of our work on behalf of the West End Partnership.

CRP have commissioned former Head of Freight & Fleet at Transport for London, Ian Wainwright, to support the development of this draft plan, in consultation with key public, private and community stakeholders.

This framework of actions will help develop the West End's status at the heart of a leading global city; with innovative approaches to deliveries and servicing that focus on ensuring the health and vibrancy of London in the context of Oxford Street's Transformation.

Some actions will be immediate, providing quick wins that build on the great work that West End Partnership members are already delivering for residents, businesses and visitors. Other, longer-term activities will deliver the next step change in reducing the numbers of deliveries and servicing vehicles in the West End.

The draft Freight Action Plan for the West End will be presented to the West End Partnership Board for comment and review.

TfL Deliveries Reduction Funding for Heart of London Business Alliance



As part of CRP's support for Heart of London's Air Quality programme, CRP secured £42,000 worth of funding from TfL to implement a waste consolidation project in the BID area.

This localised physical consolidation of wastes will work hand in hand with Heart of London's recent appointment of 2 preferred suppliers, Westminster City Council and Paper Round. The programme will ensure a reduction in the number of waste collection vehicles operating in the area, helping to improve streetscape and air quality in the West End.

Low Emission Logistics (LEL)















CRP has been busy working with seven London boroughs as part of the business engagement stage of a Mayor's Air Quality funded Low Emission Logistics (LEL) project, looking at reducing emissions and congestion through joint procurement and delivery retiming and consolidation.

The CRP team is working with local town centre managers and BIDs to collect baseline data businesses in specific areas identified by the boroughs, which will be used to provide a snapshot of current deliveries

Marylebone Low Emission Neighbourhood – Smarter Deliveries



CRP is working to change behaviour and find efficiencies with businesses in the <u>Marylebone Low Emissions Neighbourhood (LEN)</u>. Through better management of freight deliveries (including personal deliveries), we can reduce the number of freight movements throughout the Marylebone LEN.

To date, CRP has visited 138 businesses, with 30 businesses filling out the <u>deliverBEST</u> questionnaire, receiving recommendations and offers of further support. Also, with Christmas fast approaching, CRP and the Marylebone LEN Business Improvement District partners are promoting the <u>Click. Collect. Clean Air.</u> website to encourage people to receive deliveries nearer home, making Marylebone a cleaner air neighbourhood this winter.

Last month, representatives from the City of London Corporation and Better Bankside Business Improvement District (BID) joined CRP at our <u>Freight TAILS</u> transnational network meeting in La Rochelle, France. The meeting – led by our network experts – Philip Stein and Ian Wainwright, focussed on the role of voluntary behaviour change (VBC) in improving freight practices in our home cities. We addressed related issues including

- incentivising the use of zero- and low-emission vehicles;
- balancing VBC with regulation; and
- improving delivery consolidation practices.

Following the meeting, Maria Curro of Better Bankside BID stated:

"The Freight Tails (La Rochelle) conference was very relevant to the current congestion issues facing London today. The topics discussed have been very helpful in shaping the freight programme for the Better Bankside Business Improvement District. Specifically, the behaviour change discussion has shaped how we engage with businesses around business-related freight and personal deliveries. It was most helpful to speak with the European delegates and learn how other cities are working to address issues and concerns around freight."

Tom Parker from the <u>City of London Corporation</u> also found the meeting relevant to his organisation, stating:

"The Freight TAILS La Rochelle event provided an excellent opportunity for the City of London to expand knowledge on stimulating behaviour change with various groups in the supply chain. The experience will be a clear assistance in developing effective policy when working with stakeholders in the square mile."

Freight TAILS is a network of 10 European cities focused on improving the impact of urban freight transport. Please email <u>Charlotte Knell</u> or <u>Sefinat Otaru</u> for more details.

London's first <u>urban market focused delivery and servicing plans</u> were delivered by the <u>Central London Sub Regional Transport Partnership (CLSRTP)</u> programme last year. CRP is now expanding on this innovative project by working with our partners to deliver on the actions identified.

We are excited to be in discussion with Islington Council and <u>Angel BID</u> to explore a waste oil consolidation project and Lambeth Council and <u>We Are Waterloo BID</u> to deliver a sustainable solution to disposable packaging.

The aim of the these schemes is to demonstrate a positive impact relating to deliveries and servicing. For example, a reduction in vehicle movements, congestion, local air quality improvement and improvement against TfL's Healthy Streets indicators.

Waterloo Bus Garage Visit



CRP's Deliver London Team toured Go-Ahead London's Waterloo Bus Garage recently to understand the requirements and operation of Europe's largest fleet of fully electric buses. 46 electric buses operate from the Waterloo site on the 507 and 521 routes in Central London. The buses have now been operating for two years with an excellent running record, and feature service innovations such as USB charging points and audio-visual digital information screens with route maps and stop announcements.

To charge all 46 buses, the local electricity grid infrastructure needed to be upgraded. This is a costly and disruptive exercise that not many operators, whether of buses or freight fleets, will be able to pursue. The CRP <u>Smart Electric Urban Logistics (SEUL)</u> project is exploring ways to use existing infrastructure more efficiently and thereby reduce the need for future physical infrastructure upgrades.

FREVUE Successful Completion




The Final Report of the 4.5-year Freight Electric Vehicles in Urban Europe project (FREVUE) project has now been completed and submitted to the project funder, the European Commission. Overall, the impact of FREVUE has led to the deployment of 86 fully electric vans and trucks, 75 charging posts, and significant direct environmental benefits such NOx savings of 2147.5 kg.

Reports, factsheets and publications from the results of the project, are now all available on the <u>FREVUE</u> website and will assist with the further uptake of electric freight vehicles in urban Europe.

CamdenAbility and the Francis Crick Institute



CRP's innovative disability employment initiative, <u>CamdenAbility</u>, recently supported Apleona at the Francis Crick Institute to recruit a new starter for their housekeeping team.

Apleona are a cleaning and maintenance contractor at the Francis Crick Institute in St Pancras. They joined CamdenAbility in order to review their disability policy and work with the project to create a new recruitment strategy to attract local, job-ready disabled candidates.

Apleona agreed to implement a flexible approach and adapted their normal recruitment process, removing a number of barriers presented by the process for applicants with additional needs. Rather than relying entirely on the results of a competency based interview, Apleona met with a local CamdenAbility candidate, Joseph, for an informal meeting, progressing to a short work trial where he was able to demonstrate his ability, and be assessed for the role.

Joseph, 39, has a learning disability and had never worked before registering with CamdenAbility in June. After the successful work trial, he was offered a permanent position and began working. CamdenAbility also supported Apleona by advising on small adjustments needed in order for Joseph to understand and fulfil his daily tasks.

Working with CamdenAbility is an easy process. There is lots of support."

I secured a part-time role with Primark through the excellent support of Nathalie from ReStart and Ilona from Recruit London. Ilona has supported me with my welfare benefits, training and my housing situation. Both Nathalie and Ilona communicate with me on a regular basis, helping me to settle back into work. I am very excited to say that I have now worked in Primark for more than six months, and it is an amazing feeling that I can provide for my children independently rather than solely relying on state support.
