Welcome to Cross River Partnership's April Update





CRP's CamdenAbility project works with a network of local employers to improve disability standards and create opportunities for Camden residents with disabilities and longterm health conditions. The project is funded by <u>Camden</u> <u>Council</u> and delivered in partnership with the <u>Business Disability</u> <u>Forum</u>. Already, in the first quarter of 2019, 15 new disabled residents have been supported, 5 jobs created and 6 work experience placements arranged. <u>Read more</u>.





Applications are now open for <u>Good Growth Fund</u> development funding to directly support London's street and covered markets. This revenue funding can be used to support the development of projects with costs including feasibility, viability, business planning and commercial/property advice, ahead of a Good Growth Fund capital funding application. <u>Read more.</u>
