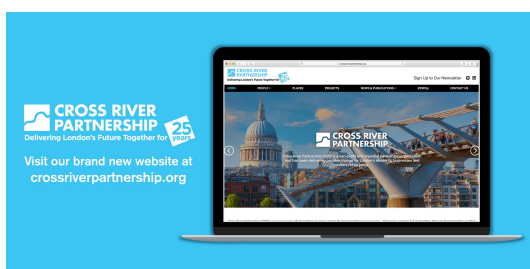
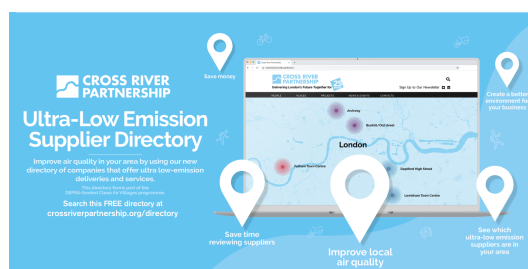




Welcome to Cross River Partnership's May Newsletter
