If yes, then the AQ Ambassador Programme might be the perfect endeavour for you! We're looking for enthusiastic, passionate individuals who are eager to learn and make a difference in their local community. The AQ Ambassador Programme is London's firstever initiative to help citizens pave the way to cleaner air in our very own neighbourhoods. Ambassadors will attend 3 Air Quality Workshops provided by Cross River Partnership team, where you're learn:

- How cycling and walking can improve air quality
 – and our health!
- The impact of deliveries on our local air quality and the alternatives that already exist!
- Personal vehicles and air pollution can EVs really improve our air quality?

AQ Ambassadors will be provided with 1-2-1 support to help build and develop localised solutions to air quality in their community. They will also be provided with a digital toolkit containing all the essentials needed to advocate for better air quality and special access to CRP resources and guidance!

Why does air quality matter?

Around the world, 9 out of 10 people are breathing air that contains high levels of pollutants¹.

Some of the most common – and dangerous – air pollutants we are exposed to are particulate matter (PM) and nitrogen dioxide (NO₂). These pollutants put people at risk of stroke, heart disease, chronic obstructive pulmonary disease, lung cancer and acute respiratory infections and are responsible for nearly 7 million premature deaths every single year (WHO).

In London, an estimated 9,500 people a year die from long-term exposure to air pollution². Over 2 million Londoners, including 400,000 children³, are living in areas that exceed the legal air quality limits. That's 1 in 4 London residents who are regularly exposed to poor air quality and harmful pollutants.
