West End Project Coronavirus (COVID-19) update

Due to the impacts of Coronavirus (COVID-19) our West End Project contractors Eurovia have closed down the main sites of Gower Street and Princes Circus. Barriers remain around areas on Princes Circus but all other areas are cleared.

The site continues to be monitored by a small team on site and the 24-hour contact number and email address will still be active should you need to get in touch.

This pause will have an effect on the programme and updates will be added to the website as the full impacts become clear.

Whitfield Gardens Update

Work is currently continuing in Whitfield Gardens. Idverde are closely monitoring the situation and reviewing daily. The team have completed digging to the new level and are protecting the roots of the trees from damage. The initial work to the mural has been completed with the artists now on site working on the painting. The locations for all the new lights have been prepared and the first delivery of furniture arrives this week for installation. We are working hard to ensure as little noise as possible is generated on the site but we would like to thank nearby residents for their patience and understanding while work continues.

Coronavirus information for businesses

Can you support young people with virtual work experience?

We are calling on Camden employers to be part of a pioneering Virtual Work Experience Programme, providing local students, with their first experiences of work this June/July.

We know that many Camden students will have had their crucial first experiences of work cancelled. Work experience has a significant positive impact on young people's outcomes, particularly on those from disadvantaged backgrounds.

So, this is why Camden has partnered with Speakers for Schools – a national educational charity backed by employers including the Bank of England, BP, Marie Curie and Spotify – to offer STEAM Pledge employers the opportunity to provide Virtual Work Experience (VWEX).

Can you help donate Laptops and iPads to help vulnerable pupils learn at home?

Camden Council is asking businesses to donate spare laptops and iPads for vulnerable students who don't have a device at home to help them to access vital online learning while schools are closed.

The Council is also working with Camden Learning, schools, community groups and local businesses to find ways to ensure pupils have a Wi-Fi connection in their homes.

If a business has laptops or iPads that they can donate to a school in Camden that are less than five years old and in good condition, we will collect them and work with schools to distribute them to children who most need them.

Companies can also make financial donations and sponsor schools to help purchase or repurpose laptops for students.

Are you due a grant payment?

There are two grant funding schemes, the Small Business Grant Fund and the Retail, Hospitality and Leisure Grant Fund. We know many smaller businesses have not yet received their grant payment from us and we are urging you to get in touch to see if you are eligible.

So far, the council has made 1,549 awards of the £25,000 government business grant, totalling £38.75m. Staff from the business rates team are currently processing the forms already received from the remaining eligible businesses for both the $\pm 10,000$ and $\pm 25,000$ grants.

If you received small business rates relief as of 11 March 2020, you'll be eligible for a Small Business Support Grant Fund payment of £10,000. This includes those in receipt of tapered relief (where your rateable value falls between £12,000 - £15,000). We will not make awards retrospectively, where the relief is not currently in place, except in exceptional circumstances.

Properties whose liability is calculated using the small business multiplier (where your rateable value is above £15,000, but below £51,000) but are not in receipt of small business rates relief, will not qualify for this grant.

If your business is in the retail, hospitality or leisure industry, you'll be eligible for a grant payment through the Retail, Hospitality and Leisure Business Grant fund. If your rateable value is $\pounds15,000$ or less, you'll be entitled to a grant of $\pounds10,000$. If your rateable value is greater than $\pounds15,000$ and less than $\pounds51,000$, you'll be entitled to a grant of $\pounds25,000$. State Aid limits are applied, meaning they are capped at an 800,000 euro limit per company.

If you pay business rates by direct debit or where we already hold your bank details, the grant will automatically be transferred into your bank account so you don't need to do anything. If you have not received a grant please share your bank details with us by <u>filling in this form</u> so that we can make the payment or call us on 020 7974 6460.

Coronavirus information for Residents

Accessing Financial Support

If you are struggling with your finances as a result of Coronavirus (COVID-19) or you know someone who is, listed below are some of the ways you can access support. We are here to help so if you are struggling in any way, get in touch.

1. If you are facing immediate financial hardship – e.g. you have no income or money in your account – you can apply for a one-off payment of around £50 through our Local Welfare Assistance Fund (LWAF) to buy groceries or pay a bill. You can <u>apply yourself</u> or by calling us on 020 7974 4444 (option 9).

2. Check you're claiming all the benefits you are entitled to including our Council Tax Support scheme which reduces the amount of council tax residents are required to pay.

3. If you are receiving Council Tax support already and have something left to pay, you should have received a letter from us about a further discount - let us know if you haven't.

4. If you don't receive Council Tax support already and earn less than £387 per week (or less than £483.75 if you have children, are living with a disability, or you're are a carer), you will be eligible for a discount. If you earn less than £86 per week, you won't pay anything at all but you need to apply for this discount <u>online</u> or by calling us on 0207 974 4444 (option 9).
