

CRP's Next Lunchtime Launch Event Railway Infrastructure: Dawn of a New Era?



Sign up for CRP's next Lunchtime Launch event '<u>Railway Infrastructure: Dawn of a New</u> <u>Era?</u>', **Thursday 29th July, 1:15pm - 2pm**, to discuss the potential future of urban rail freight and additional uses for railway infrastructure. We will be joined by <u>Camden Town</u> <u>Unlimited</u> and <u>Better Bankside</u> to explore both the <u>Camden Highline</u> and the <u>Low Line</u>!


Hasanul Hoque, Operations Director at <u>Camden Town Unlimited</u>, will be presenting on the BID's sustainable green development project - the <u>Camden Highline</u>. The route is 1.2km long, around 8 metres above ground and will bring new local green space to 20,000 people.

Val Beirne, Bankside Urban Forest Manager at <u>Better Bankside</u>, will be presenting on the BID's Low Line, an urban regeneration project along the railways viaducts in South London, from Bankside to Bermondsey. Like the Highline, Better Bankside are opening up stretches for walking and cycling and bringing forward green spaces, as well as launching the Green Logistics Centre, a freight reduction pilot.

CRP will also be sharing findings on rail freight from the <u>Defra</u>-funded <u>Clean Air Villages</u> <u>4</u>(CAV4) programme. Whether it's taking vehicles off the roads or transporting goods in a more efficient way, rail freight deliveries can provide a faster, greener, safer and more efficient way of transporting goods than via road.


CAV4 already has underway:

- An interactive map of sites available for micro logistics hubs
- A range of cargo bike trials to support businesses of all sizes on their sustainability journeys
- Shared electric vehicle schemes
- Free dongles to help businesses gather vehicle data that will drive informed decision-making
- Focus group research on walking freight possibilities
- A river freight trial and feasibility study on the potential of Thames piers for freight alongside passengers
- A full programme of <u>Lunchtime Launch</u> online events
- Improvements to the measureBEST air quality quantification tool
- Updates to the CRP Clean Air Villages Directory
- Materials to promote air quality policies to different audiences e.g. the Mayor's ULEZ

# Healthy Streets Everyday update



It has been a busy month for the <u>Healthy Streets Everyday</u> (HSE) project at CRP, with the launch of 3 case studies and a mural competition for schools. The case studies have been showing some of the excellent work our partner boroughs have been doing using their Healthy Streets Everyday funding.

Our <u>first case study</u> looks at a brilliant new parklet on Overstone Road in Hammersmith BID, which HSE has helped to fund to provide outdoor seating and space for social distancing outside the Dartmouth Castle pub.

The <u>second case study</u> explores how the <u>London Borough of Lambeth</u> and the <u>Royal</u> <u>Borough of Greenwich</u> have been implementing <u>Dr Bike</u> sessions to support safe cycling and bike maintenance, with 58 sessions held in the boroughs.

Thirdly, the <u>London Borough of Richmond</u> has purchased 26 wearable air quality monitoring devices to help support evidence-based decision making and inform officers of the pollutant challenges in specific, local areas. You can read more <u>here</u>.

We have also recently launched a new competition for schools to participate in for **Car Free Day 2021**. # **Retrofit for the Future**

An exciting refurbishment as part of <u>Clean Air Thames</u> will see the <u>Port of London</u> <u>Authority</u>'s river maintenance vessel Drfitwood II fitted out with equipment to reduce its pollution emissions! Selective catalytic reduction (SCR) technology will reduce nitrogen oxides emitted from the vessel's exhaust.

CRP is excited to be working with the <u>Mayor of London</u> to continue to improve air quality along the Thames. More information on future vessel retrofits will be announced later in the summer so stay tuned!

### **Decarbonising Transport: A Better, Greener Britain**



On 14th July 2021, the <u>Department for Transport</u> has released its <u>new strategy for</u> <u>Decarbonising Transport</u> to set out the UK's plan to achieve net zero transport by 2050.

The plan sets out key commitments that link to CRPs projects such as <u>Clean Air Villages 4</u>, <u>Healthy Streets Everyday</u>, <u>Clean Air Thames</u> and <u>CLSTRP</u>, with actions around:

- Creating a world class walking and cycling network by 2040 in England, including investing £2 billion over the next 5 years so that half of all journeys in cities and towns can be walked or cycled by 2030
- Increasing the provision of zero and ultra-low emission public transport infrastructure across the UK on our trains and buses
- Improving rail journey connectivity for walking and cycling to create multi-modal journeys
- · Increasing zero emission vehicles across the UK
- Support and encourage modal shift of freight from road to more sustainable
  alternatives, such as rail, cargo bike and inland waterways



#### New report launched

#### 'Freight Noise Management in Urban Environments'



CRP is excited to announce the launch of its <u>latest report</u> which explores effective technological solutions to monitoring delivery-related neighbourhood noise and air pollution, aiding landowners, freight operators and local authorities to test best practice when retiming of deliveries is being considered to counter peak-time congestion in London.

To celebrate the launch, <u>EMSOL</u>, <u>Cadogan</u> and CRP recorded a discussion of the findings from the study and give their views of how new monitoring technology could benefit communities affected by noise and air pollution, and what the next steps should be. <u>Watch the event!</u>

The study was commissioned on behalf of the <u>Central London Sub-Regional Transport</u> <u>Partnership</u> (CLSRTP) with air and noise quality consultant, <u>EMSOL</u>, undertaking the research between 5th August - 14th December 2020. CRP partner <u>Cadogan</u> were the hosts of the site chosen for the data collection, which was the popular Pavilion Road in the <u>Royal Borough of Kensington and Chelsea</u>.

24 location tags were issued to participating business vehicles which made deliveries to Pavillion Road throughout the research period. Noise and air quality monitors were then set up in the delivery drop-off location.

#### Key findings from the study showed that:

- · The loudest parts of the day were typically 10am till 2pm.
- Night time (11pm 7am) noise levels did not drop below 50dB, which is considered as a moderate annoyance in the WHO guidelines.

- Friday represented the noisiest day of the week, while Sunday was the quietest.
- Some correlation was observed between vehicle visits and noise level on the site.
  - The PM10 and PM2.5 concentrations at the site were relatively high. To identify if there were specific vehicles coming on site that are especially polluting, it would be required to tag more vehicles.
  - The project was able to show that a combination of noise monitoring and vehicle tracking technology can be used to measure the impact of delivery activity on noise levels.

CRP is currently working with the CLSRTP on new research to develop a Vision for Central London's Street Space, which is expected to be later this summer!

#### Net Zero in City of London

UK Power Supplier E.ON has started work on a £4m project to install one of the UK's largest zero carbon heating and cooling systems beneath the streets of London.

The heat pump is being installed in the heart of London's square mile, and will draw from the natural warmth of the earth as well as recycling waste heat from power generation. This energy can be stored in three boreholes extending 200m



below the capital and provide zero carbon heating and cooling for buildings.

The project will provide 4MW of extra heating capacity and a further 2.8MW of new cooling capacity to customers across the <u>City of London</u> – this is a fantastic initiative.

CRP looks forward to sharing the best practice developed by this project at its future <u>CRP Board</u> meetings.

# Free online short course on Healthy Urbanism launched

University College London researchers Dr Helen Pineo and Dr Gemma Moore have co-developed a free online training course on '<u>Healthy Urbanism</u>'.

Lack of knowledge of how the built environment influences the health of the public is a key barrier to building and maintaining healthy places. The pandemic and growing health inequalities have highlighted the importance of this topic, yet many lack the skills to act.

Researchers received funding to develop this course with an advisory group including representatives from; <u>Public</u> Health England, <u>Faculty of Public</u> Health, <u>Guy's & St Thomas' Foundation</u>, London Healthy Place Network, <u>Royal</u> Institution for Chartered Surveyors, <u>Royal</u> Town Planning Institute, <u>Town & Country</u> <u>Planning Association</u> and other orcanisations.

The course is aimed at built environment and public health professionals and postgraduate students, including those working in planning, engineering, architecture and other fields. The total time to complete the course is 3.5 hours, however, participants can complete content at their own pace.

CRP's Mayor of London-funded Healthy. Streets Everyday project is proactively working with 26 partners to make lasting and transformative change to streets throughout London. The programme is helping to aid London's continued response to the pandemic by enabling walking and cycling through initiatives such as school streets and car-free zones.
