

Funding Success: Clean Air Logistics for London



We are very excited to announce that we have been successful in our funding application to the [Defra Air Quality Grant Scheme](#) to launch [Clean Air Logistics for London \(CALL\)](#).

The project will move more freight into London via river rather than road, supported by a network of highly visible zero emission delivery methods across the Central London area, including Electric Vehicles, Cargo Bikes and Walking Freight. The CALL project will be delivered over the period 1st July 2022 – 30th June 2023, with ongoing Air Quality improvements continuing beyond the life of the project.

The [City of Westminster](#) are the lead authority and there are ten project partners in total: [London Borough of Hammersmith and Fulham](#), [London Borough of Islington](#), [London Borough of Lambeth](#), [London Borough of Lewisham](#), [London Borough of Southwark](#), [London Borough of Wandsworth](#), [Port of London Authority](#), [The Fitzrovia Partnership](#), and [Cadogan](#).

As part of the [Clean Air Villages 4](#) (CAV4) project, CRP is collaborating with [Geotab](#) to provide businesses with telematic dongle devices in order to carry out a free EV suitability assessment. This is a personalised report highlighting whether switching to an EV is a suitable option for your business.

If you are interested in understanding more, please complete our [short Electric Vehicle Survey](#) or email CRP stating your interest. We will then send you a free telematic dongle(s) to use for three months to monitor your vehicles' driving speeds, distances, daily mileages, times, and parking locations. New Healthy Streets Everyday Report Launched

MAKING SCHOOL STREETS HEALTHIER: Learning from temporary and emergency closures

March 2022



Last week saw the launch of new report '[Making School Streets Healthier: Learning from Temporary and Emergency Closures](#)'. This report was written by [University of Westminster's Active Travel Academy](#) PhD researcher Asa Thomas and part-funded through CRP's [Healthy Streets Everyday](#) programme.

During the pandemic, many School Streets were brought in as temporary and emergency measures across London, to aid with social distancing, improving air quality and encouraging active travel to school.

This report focuses on two School Street schemes on Fairholt Road and Rendlesham Road in the [London Borough of Hackney](#), to evaluate their impact and effectiveness. The research utilised Vivacity's monitoring tools to provide spatial, vehicular and time data to examine how the area was used and the changes over time as a result of the School Street.

The report finds that School Streets lead to significant reductions in traffic both during the closure time and over the whole day, a minimal change in pedestrian numbers and use of space and improvements in several Healthy Streets indicators. It also provided recommendations for enhancing the positive aspects of School Streets.

River Freight Guide for Businesses Launched in April

The guide includes a case study with [DHL](#), who have been delivering on the river since 2018, as well as information, terminology and relevant groups and contacts which will help businesses to implement a river freight trial.

River freight can help to reduce road traffic and air pollution, as well as being more reliable and providing an easy way to access Central London.

CRP's new Clean Air Logistics for London project, starting in July 2021, will focus on river freight and further making the underused Thames a viable route for goods coming into London.

Southwark Council Approves Sustainable Plan

The [Southwark Plan 2022](#) was adopted by the [Southwark Council Assembly](#) on 23rd February. The plan, which replaces several older versions of development plans, sets out the vision, strategic objectives and brings together all the council's planning policies and strategic targets for new homes, new jobs, open space and different types of development, while preserving and celebrating the borough's history and heritage for the period 2019 to 2036. It forms the statutory development plan for the borough, along with the [London Plan](#).

Have you heard about the [Mayor's Business Climate Challenge \(BCC\)](#)? The BCC, developed with support from [Bloomberg Associates](#), is an energy efficiency programme which supports businesses to reduce their energy consumption, to accelerate building decarbonisation efforts in London.

Emissions from heating and powering London's commercial and industrial buildings currently make up 36% of the capital's carbon footprint.

The programme provides free support to help make buildings more energy efficient, reduce costs and support businesses on their pathway to zero carbon.

Last year, the Mayor partnered with [Better Bankside BID](#). 19 businesses joined the BCC, agreeing to reduce their building's energy consumption by 10% within the first year! The GLA are now looking for ten business engagement partners to help deliver the expanded programmes. These can be Business Improvement Districts, Climate Change Alliances and Town Teams.

This year, the BCC will support a further 250 businesses to decarbonise their buildings and reduce their energy bills. Businesses signed up so far include [London Marathon Events](#) and [Paper Round](#).
