CRP is delighted to announce its continued commitment to delivering sustainable logistics solutions by supporting the development of a low-emission micro logistics hub in the City of Westminster. This initiative, funded by [Westminster City Council's \(WCC\) Carbon Offset Fund](#), aligns with the Council's climate action goals while addressing the challenges of freight-related emissions and traffic congestion.

The proposed micro logistics hub will optimise last-mile deliveries through innovative consolidation practices and the promotion of zero-tailpipe emission transport modes such as e-cargo bikes.

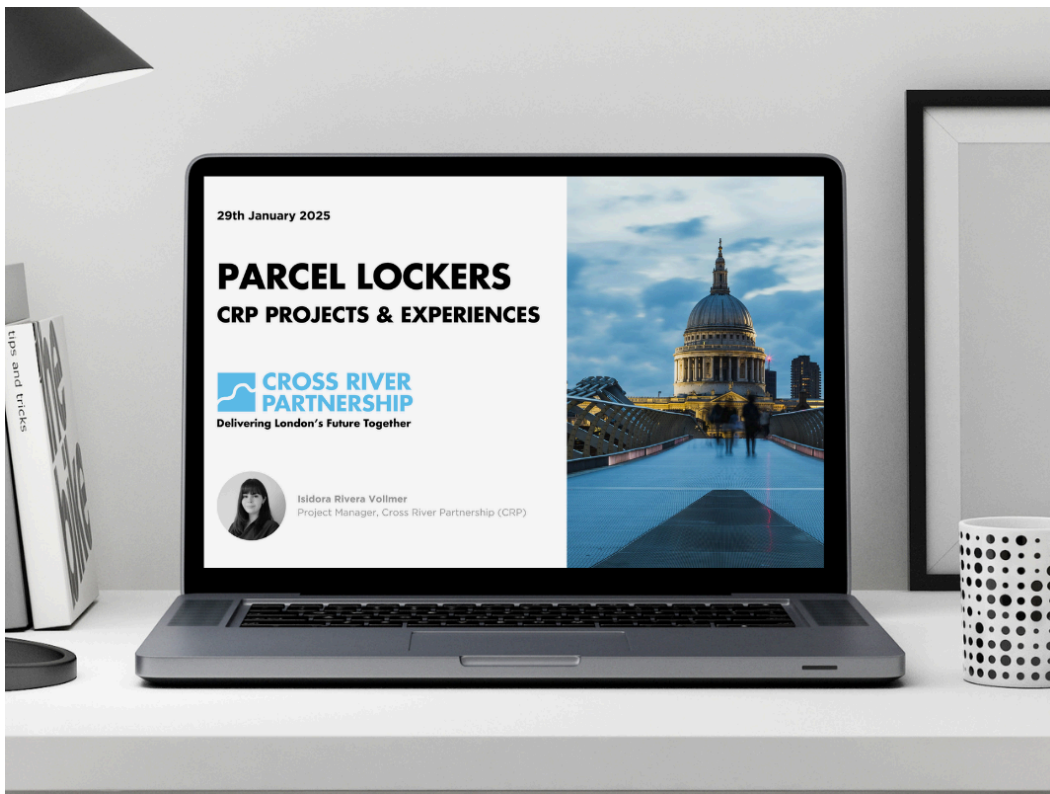
At a project wide General Assembly meeting held this month, CRP shared progress and learnings with our 32 international project partners.
