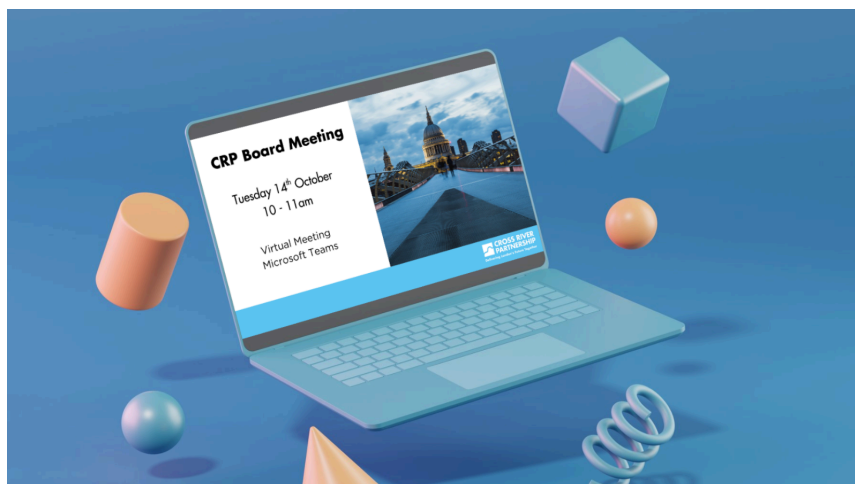

Clean Air Routes London is a new interactive map that helps you find routes with the best available air quality.

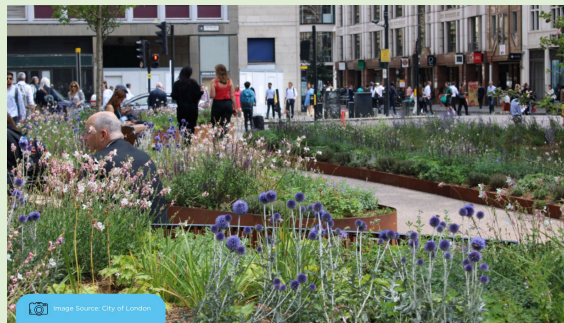
The website uses forecasted air quality data, to guide residents, workers and visitors on cleaner, healthier journeys, helping to minimise their exposure to harmful air pollution.

Clean Air Routes London has been developed by **Westminster City Council** in partnership with **Cambridge Environmental Research Consultants** (CERC) and supported by the **Department for Environment, Food and Rural Affairs** (DEFRA).

London meets legal limits for toxic NO2 pollution for the first time



London meets legal limits
for toxic NO₂ pollution

Leading experts at **King's College London** estimated that, from when the **Mayor of London** Sadiq Khan came into office in 2016, without additional action it would take 193 years for London to meet legal limits. Independent Government data shared earlier this month, revealed that London's air pollution levels fell to within the legal limits for nitrogen dioxide (NO₂) for the first time in 2024.

This rather remarkable nine-year shift shows that bold policy and action can produce important benefits. Ambitious London-wide policies, such as ULEZ (Ultra Low Emission Zone), have supported to nearly half levels of toxic NO₂ at roadsides.

Here at CRP we are championing and contributing to this exciting clean air journey! From healthier streets and greening to low-emission freight and active travel infrastructure, CRP and its Partners are making an impact across London.
