

Cross River Partnership Announces New Board Co-Chair

[Cross River Partnership](#) (CRP) is pleased to announce the appointment of Nadia Broccardo, Chief Executive Officer of [Team London Bridge](#) Business Improvement District (BID) as its new private sector Board Co-Chair.
